## APPENDIX TWO - AEB Data 2022/23

Headline data is available at local authority level and will be shared with individual authority officers in due course.

### Learner and Learning Volumes

In summary devolved AEB funds in 2022/23 supported:

- Total number of Learners: 35,480, participating in 65,920 Learning Aims
- 4,450 learners accessing entitlement qualifications
- A gender split of Male Learners 43% Female Learners 57%
- As a proportion of total learners the proportion of BAME Learners was 24%
- As a proportion of total learners the proportion of Learners with a disability/learning difficulty and or health issues totalled 23%
- 75% (19,230 learners undertaking 35,680 learning aims and accounting for over £28.6m of funds) of all adult skills funded learners live in disadvantage uplift areas, with 68% of learners living in the most deprived quintile of Indices of Deprivation listed wards.

# Sector Based Work Academy Programmes (SWAPs) support and paid job outcomes

- Learners benefiting from SWAPs in 2022/23 totalled 930 learners being supported through 1260 learning aim enrolments.
- Learner demographics inform that: 67.7% of learners were male with 32.3% being female; 15% were BAME learners; 22.6% were aged 19-23, 55.9% were 24-49, whilst 21.5% were aged 50 and older. 23.6% of learners reported a learning difficulty or disability.
- LCRCA allows payment of a job outcome for providers, however many choose not to claim the payment in favour of supporting learning with their allocation. In 2021/22 160 job outcome payments were claimed.

### Percentage of delivery through Adult Skills and Community Learning

- Learners on Adult Skills provision represented 25,510 learners undertaking 46,090 learning aims.
- Learners on Adult Community Learning represented 14,190 learners undertaking 19,830 learning aims.
- 15,090 or 42% of learners engaged in priority sector related provision

### Of the Adults Skills element:

- 17.4% of learners funded through adult skills undertook Statutory Entitlement provision, representing 16.9% of adult skills funding (£6.1m) further detailed below.
- The most popular Sector Subject Areas (SSA) at Tier 1 were: SSA14 -Preparation for Life and Work; SSA01 - Health, Public Services and Care, SSA15 – Business, Administration & Law and SSA07 - Retail and Commercial Enterprise.

### Number of learners exercising their statutory entitlement to full funding

Statutory Entitlements enable eligible learners to be fully funded for the following qualifications:

- English and maths, up to and including level 2, for individuals aged 19 and over, who have not previously attained a GCSE grade 4 (C), or higher, and/or
- first full qualification at level 2 for individuals aged 19 to 23, and/or
- first full qualification at level 3 for individuals aged 19 to 23
- essential digital skills qualifications, up to and including level 1, for individuals aged 19 and over, who have digital skills assessed at below level 1
- In 2022/23 4,450 learners engaged in statutory entitlement provision across 6,310 learning aims.
- The LCRCA places the delivery of statutory entitlements as a key priority of devolved AEB and in tackling the skills gaps that exist across the region in relation to national figures.
- Statistics relating to statutory entitlement funded through Adult Skills provision are provided in the table below:
